**TRAINING FOR TRAINERS ON THE OPERATIONS OF THE MONTRAN REAL TIME GROSS SETTLEMENT (RTGS) SYSTEM**

You are therefore, kindly requested to ensure that nominated participants attend this important training programme. It is envisaged that participants trained under this programme will in turn train other members of staff on the operation of the new system within your respective institutions.
