PROVISION OF FOREIGN EXCHANGE MARKET DATA

The above subject matter refers.

All commercial banks are hereby advised that they are required to submit to the Bank of Zambia the following information with immediate effect:

- (i) All confirmed and unconfirmed foreign exchange transactions of US\$100,000.00 and above;
- (ii) All pipeline deals, i.e. customer enquiries and orders of US \$100,000.00 and above.

This information should be completed in the attached template and submitted daily to the Bank of Zambia through email address, finkreturns@boz.zm at the time intervals of 09:00 hours, 12:00 hours and 15:00 hours. This information must include transactions with foreign banks.

Please note that Commercial Banks are required to continue submitting the foreign exchange returns and schedules by 09:00 hours on the following business day.
