The Monthly Prudential Returns and Credit Market Monitoring Programme (CMMP) Returns should be submitted through the Bank Supervision Application System via <a href="https://bsa.boz.zm/bsa">https://bsa.boz.zm/bsa</a> while a soft copy of the Bank Charges Returns should be submitted to <a href="mailto:banksupervision@boz.zm">banksupervision@boz.zm</a>.

A penalty of K500.00 per return per day will be charged for any delayed submissions or incorrect Prudential, CMMP and Bank Charges Returns.

In case of Quarterly Financial Statements, a penalty of K1,500.00 per return per day shall be incurred in any of the following circumstances:

- Failure to submit the quarterly financial statements;
- Failure to obtain Bank of Zambia approval prior to publication;
- Publication of financial statements using incorrect formats; and

Publication of incorrect information.
