**Determination of Government Securities as an Additional
Asset Class for Minimum Reserve Requirement**

NOTICE IS HEREBY GIVEN that, pursuant to Section 47 (1) (c) of the Bank of Zambia Act, 2022, with effect from Monday, June, 3rd 2024, Government Securities issued by the Government of the Republic of Zambia shall be an additional asset class to be considered for the purposes of complying with minimum reserve requirements. The Bank of Zambia shall specify the eligible Government Securities for this purpose, and these shall not exceed a prescribed quantum of the minimum statutory reserve requirements.
