1.0 Introduction


This report analyses Zambia's direction of merchandise trade in the fourth quarter of 2019 compared to the corresponding quarter in 2018. Statistics based on the Harmonised Coding System (HS) are reported and exports are valued as free on board (f.o.b.) while imports are reported at cost, including insurance and freight (c.i.f.).

2.0 Major Destinations for Zambia's Exports

Major destinations for Zambia's exports remained Switzerland, China, Democratic Republic of Congo (DRC), Singapore, South Africa, and Tanzania

Total exports earnings were US\$1.8 billion in the fourth quarter of 2019 compared to US\$2.2 billion in the corresponding quarter in 2018. This represents a decline of 18.6% (Chart1). The decline in copper exports to Switzerland due to the reduction in export volumes and average realized prices largely explain the sluggish performance of exports. The fall in copper exports largely reflected the lingering effects of the 5.0% import duty on copper and cobalt concentrate that led to a slump in concentrate imports. Temporary shut-down of operations at some mining companies also contributed to decrease in production and export volumes. However, exports to China and South Africa improved slightly following increases in copper and articles thereof, as well as base metals and cermets, respectively (Table 1).

Chart 1: Major Export Destinations (US\$ millions)








Chart 2b: Export Earnings, Excluding Copper (US\$ millions)

Chart 3b: Q4 2018 and Q4 2019 Major Export destinations for natural/cultured pearls, precious stones and metals (US\$ millions)








Chart 3d: Q4 2018 and Q4 2019 Major Export destinations for other base metals, cermets and articles thereof (US\$ millions)

3.0 Major Source Countries for Zambia's Imports


Major source countries for Zambia's imports remained South Africa, China, United Arab Emirates, Japan, and India in that order

Merchandise imports were US\$1.7 billion in the fourth quarter of 2019 compared to US\$2.4 billion in the corresponding quarter in 2018. This represents a decline of 28.6%. The decline in imports was broad based, largely reflecting subdued domestic economic activity and declining real incomes.

A reduction in imports of nuclear reactors, boilers and mechanical appliances from South Africa, China and United Arab Emirates largely explained the decline in imports. The slowdown in domestic economic activity could have dampened demand for these commodities. In addition, lower imports of pharmaceutical products also contributed to lower imports during the quarter (Table 2).

Imports from the top five source countries accounted for 65.9% of total imports with South Africa being the highest contributor, at 31.5% (Table 2).





Chart 5: Major Import Commodities (US\$ millions)





Chart 6a: Source countries for mineral fuels, oils and products of their distillation (US\$ millions)





Chart 6d: Source countries for vehicles and vehicle accessories (US\$ millions)





Chart 6e: Source Countries for electrical equipment and parts thereof (US\$ millions)




4.0 Conclusion

Trade was lower in the fourth quarter of 2019 compared to the corresponding period in 2018. It declined by 25.9%, explained by a larger reduction in imports than export earnings. Due to weak domestic demand, imports slumped with a broad based decline across most products. The sluggish performance in exports was mainly due to reduced earnings from copper occasioned by a fall in both copper export volumes and average realized prices.
